EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013 AND SECRETARIAL STANDARD ON GENERAL MEETING

Item 1- To Increase in Authorized Share Capital and amendment in Memorandum of Association

At present the Authorized Share Capital of the Company is Rs. 49,39,26,460/- (Rupees Forty-Nine Crores Thirty-Nine Lakhs Twenty-Six Thousand Four -Hundred and Sixty) divided into 4,93,92,646 (Four Crores Ninety-Three Lakhs Ninety-Two Thousand Six-Hundred and Forty-Six) Equity Shares of Rs. 10/- each. The Company proposes to increase its Authorized Share Capital as Rs. 52,01,37,440 (Rupees Fifty-Two Crores One Lakh Thousand Four Hundred and Forty Only) divided into 5,20,13,744 (Five Crores Twenty Lakhs Thirteen Thousand Seven Hundred and Forty-Four) Equity Shares of Rs. 10 /- each as Company proposes to issue further shares to its shareholders in future. This change would necessitate an amendment to Clause V of the Memorandum of Association of the Company, which, in terms of the Companies Act, 2013 requires the members of the Company to approve the same.


