EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013 Item 1- Increase in Authorized Share Capital and amendment in Memorandum of Association

At present the Authorized Share Capital of the Company is INR 28,50,00,000 (Indian Rupees twenty eight crores fifty lakhs only) comprising of 2,85,00,000 (two crores eighty five lakhs) equity share of Rs. 10/each. The company proposes to increase its authorized share capital as 2,91,00,000 (two crores ninety one lakhs) equity share of Rs. 10/each as company proposes to issue further shares to its shareholders in future. This change would necessitate an amendment to Clause V of the Memorandum of Association of the Company, which, in terms of the Companies Act, 2013, requires the members of the Company to approve the same.


