## EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013 AND SECRETARIAL STANDARD ON GENERAL MEETING

### Item 1- To Increase in Authorized Share Capital and amendment in Memorandum of Association

At present the Authorized Share Capital of the Company is Rs 46,28,86,570(Rupees Forty Six Crores Twenty Eight Lakhs Eighty Six Thousands Five Hundred and Seventy Only) divided into 4,62,88,657 (Four Crores Sixty Two Lakhs Eighty Eight Thousand Six Hundred and Fifty Seven) Equity Share of Rs. 10/- each . The Company proposes to increase its Authorized Share Capital as Rs. 49,39,26,460 (Rupees Forty Nine Crores Thirty Nine Lakhs Twenty Six Thousands Four Hundred and Sixty Only) divided into 4,93,92,646 ((Four Crores Ninety Three Lakhs Ninety Two Thousand Six Hundred and Forty Six) Equity Shares of Rs.10/- each as Company proposes to issue further shares to its shareholders in future. This change would necessitate an amendment to Clause V of the Memorandum of Association of the Company, which, in terms of the Companies Act, 2013, requires the members of the Company to approve the same. None of the Directors are in anyway concerned with or interested in the said resolution, except to the extent of their respective shareholding in the Company.

The Board recommends the adoption of the resolution as set out in Item no. 1 of the Notice as ordinary resolution.


